About the Course

Europe's General Data Protection Regulation (GDPR) comes into effect on May 25th, 2018. Many businesses and individuals are looking to upskill in Data Privacy and Security to fully come to grips with their obligations under GDPR.

This course is designed to look at the regulatory environment for GDPR, including all relevant data protection policies and procedural documentation. Specifically, this includes areas such as:

- All internal data protection governance matters
- Role, jurisdiction and requirements of Data Protection Officers
- How to ensure suppliers or third parties are compliant via data processing agreements
- How to control a data breach and crisis management
- Dealing with the Data Protection Commissioner
- Data processing and employment matters
- Data protection matters (e.g. marketing/loyalty cards, investigating/reporting onsite accidents, insurance concerns, etc.)

After completing the course, participants will have a full understanding of GDPR for business and will be able to draft their own organisation's policies and procedures.
